

# Abortion Mass Murder in the First Degree

## THE LAW OF GOD

God said in Exodus 20:13 "You shall not murder". The law of God commands us not to murder. This includes murder of babies. Abortion on demand is first degree murder because it is premeditated and hired. Once I asked a certain OB/GYN if he performed abortions on demand. His reply was "yes" and then he proceeded to give me an example of a woman who came to him. She was already having a difficult time raising her young boy alone after the death of her husband. Now she was pregnant. The doctor said to me, "I had compassion on her and terminated her pregnancy." Instantly, my heart became heavy as I realized that this man had prostituted his medical profession. He auctioned off his dignified medical ministry to the highest bidder. He had sold out to selfish humanistic philosophy that he learned from his educators and textbooks. He lost his humble perspective of being a servant to society and in pride attempted to exalt his throne above God's. I began to explain to him that he had committed murder. I explained to him that he was trying to play God, tamper with destiny, and play with fate like a toy. He reasoned that whether that fetus was really alive or not was a matter of interpretation. He reasoned that what he did was the compassionate thing to do. He reasoned that my interpretation of the Bible was narrow and uneducated. He reasoned that if he hadn't terminated the pregnancy (murdered the child), someone else would have. As I continued to challenge his reasonings by telling him what the Word of God said, he began to tremble and his voice began to break. But in spite of hearing the truth, he insisted on justifying himself rather than repenting and receiving forgiveness.

## LEGAL VERSUS LAWFUL

John the Baptist told Herod the king that taking his brother's wife was NOT LAWFUL according to the scripture. That statement cost him his head. Herod was king. He made the laws, so whatever he decreed was LEGAL. But everything that is LEGAL is not necessarily LAWFUL. In Dr. Randy Adler's book, When Upside Down is Really Rightside Up, he shares some alarming statistics:

Under Mao Tse Tung, it was legal, but not lawful when he murdered 80 MILLION PEOPLE. "You shall not murder" Exodus 20:13.

Since the beginning of Soviet rule with the Bolshevik revolution, the leaders of the Soviet Union have legally, but not lawfully murdered 40 MILLION PEOPLE. "You shall not murder" Exodus 20:13.

Under the legal, but unlawful sanction of the U.S. Supreme Court and with the help of selfish parents, prayerless government education, yellow journalists, cowardly legislators, humanistic universities, hireling doctors, and powerless churches, we have murdered 21 MILLION BABIES. "You shall not murder" Exodus 20:13

And at the bottom of the list, Adolf Hitler legally, but not lawfully murdered 6 MILLION JEWS. "You shall not murder" Exodus 20:13.

## HISTORY REPEATS ITSELF

Child murder, child abuse, child neglect, child molestation, and child pornography are nothing new. At the decline of every empire, every nation, and every period of history, the degenerating society has always lost its respect for children and the sanctity of life. Usually, each new society has a different modus operandi of violence toward children that deceives the people from associating their violence with the method of violence used by the previously degenerated society in history. Today, the cover-ups for the abortion modus operandi are 1) the INSIDE THE WOMB issue, 2) Parents rights and, 3) the approval by the medical profession at large.

The Bible records many tragic historic examples of child destruction like child sacrifice under the idol god of Molech (II Kings 23:10). Pharaoh also murdered babies (Exodus 1:12-22). Herod murdered babies and young children (Matthew 2:16-18). And there are more Bible examples.

## CHILD vs FETUS/EMBRYO

The Bible says of Mary, "Mary was espoused to Joseph, before they came together she was found with child of the Holy Ghost." (Matt 1:18). Then later when Jesus was over 8 days old, the scripture says, "The child grew" (Luke 2:40). In other words, the Bible calls a baby a "child" in the womb and a "child" outside the womb. Actually everyone knows in their heart that an embryo or fetus is a living person, otherwise doctors and parents wouldn't try so hard to keep premature babies alive. Why bother, they are just early embryos? The "gas chambers" of Hitler were horrible but no more horrible than the "salt chambers" of the USA. The "torture chambers" of the Roman Empire were grotesque, but no more grotesque than the "suction chambers" of American vacuums. The "brutalities" of the

Japanese prisoner of war camps were diabolically painful, but no more diabolical and painful than the "scraping" of American physicians.

## **MALPRACTICE SUITS AND HEALTH INSURANCE**

The skyrocketing costs of malpractice insurance is one of the judgments of God upon the medical profession because they have allowed their peers to commit mass murder. Christian doctors have failed to "speak up". And of course these costs are passed on to the public as judgment on the whole nation for permitting murder. "You shall not murder" Exodus 20:13. Abortion is rotting the Heart of America. Abortion is a Spiritual Cancer burning our brains and conscience.

## **INCURABLE AND TERMINAL DISEASES**

Cures for HEART diseases, CANCER, AIDS, and many other diseases keep evading us. Could it be the cures for these incurable and terminal diseases are HIDDEN from us until we repent of our mass murder? Could it be that these diseases CORRUPTING our bodies are symptomatic of our CORRUPT minds that license, legalize, and rationalize first degree murder?

## **WHAT SHALL WE DO?**

Christians must repent in prayer for the sins of their nation (II Chronicles 2:14). Christians must inform women who have aborted and physicians who have performed abortions that there is forgiveness and pardon through Jesus. (Isaiah 55:7).

God-fearing people and doctors must offer abortion candidates alternative solutions, like crisis counseling and adoption counseling. (Deuteronomy 30:19).

God-fearing people must "speak-up" demanding the disclosure from doctors as to whether they perform abortion on demand. Then these doctors must be boycotted and made public record until they change their evil practices. (Ephesians 5:11).

God-fearing doctors must "speak-up" to other doctors and professional associations. Failure to "speak-up" is consent. (Ezekiel 3:18).

Christian doctors must seek positions of service, leadership, tenure, and influence in their universities, associations, and spheres of practice in order to restore the conscience of the medical profession as a whole. (Proverbs 29:2).

God-fearing people must lobby and move for legislation changing the laws and rulings. (Matthew 5:13).

And more than anything else, we must all pray for the manifestation of God's final end-time global harvest of souls and we must participate in world evangelism with our missions giving and our own witnessing. When scores of people are being swept into the Kingdom of God, the abortion problem will begin to be solved, because so many people whose values were previously corrupted have become Born-Again Christians. The primary way Christians of the early church, as recorded in the Book of Acts, fought corruption and degradation of their societies was evangelism and revival, not political lobbying and endless "Mad-Magazine" articles that only Christians read anyhow. It seems that the early Christians believed that the root problem of every ill of society was people's need for Jesus.
